Message from the Chair



I am delighted and honored to serve as the new Chair of IAMRA. This is an exciting time for our organization, as evidenced by the wonderfully successful International Conference on Medical Regulation that was just held in Melbourne, Australia. The meeting garnered the highest attendance of all of IAMRA's 12 biennial

conferences with over 500 attendees from 42 countries.

We at IAMRA wish to extend our most heartfelt thanks to our gracious hosts, the Medical Board of Australia, chaired by Dr. Joanna Flynn, and the Australian Health Practitioner Regulation Agency, led by Chief Executive Officer Mr. Martin Fletcher. The high quality of the meeting and its insightful presentations are due in large part to the efforts of our hosts and their hardworking staff members, as well as a very active and engaged Program Planning Committee. I would also like to thank IAMRA's Operations Officer, Ms. Roxanne Huff, for her tireless work in preparation for the conference and during the meeting, as well as the efforts of Dr. Alison Reid, who has attended nearly every previous meeting but attended for the first time this year as IAMRA's first Executive Director. Thank you to these individuals and several others who contributed to making IAMRA's meeting an unequivocal success!

Our Members General Assembly adopted three important resolutions at its Melbourne meeting. They involve topics essential to improving the quality of medical regulation and public protection worldwide, including the professional development of medical faculty through short-term international placements, the benefits of continued competency systems and their key principles, and a statement in support of the value of accreditation of medical schools around the world.

We also adopted, through unanimous support of the Members General Assembly, several substantive changes to our organization's <u>bylaws</u>. These changes include folding the Associate Member class into the Partner Class, expanding the number of "participating delegates" available to each member, expanding the rights of partner members, and increasing the number of positions available on IAMRA's <u>Management Committee</u> to as many as twelve (12).
